

AGREEMENT FOR A SECOND EXTENSION FOR LANDSCAPE MAINTENANCE SERVICES BETWEEN THE VILLAGE OF WOODRIDGE AND ALANIZ LANDSCAPING GROUP, INC.


The Village of Woodridge (hereinafter "Village") and Alaniz Landscaping Group (hereinafter "Alaniz") mutually agree to a one (1) year extension of the agreement that was the subject of bid #2008-04 / Landscape Maintenance Services originally entered into April 3, 2008.


The term of this second extension shall run from May 1, 2010 through April 30, 2011 at a total contract price of \$81,691.80. Both parties mutually agree that all terms and conditions of the agreement that was the subject of bid #2008-04 / Landscape Maintenance Services shall continue in full force and effect. Included in this renewal and for no additional fee are the four newly added areas which are: 1) the parcel on Mulligan Drive; 2) the Janes Avenue islands; 3) the parkway at Ross and Jackson; and 4) the planting bed at the southeast corner of 75th Street and Woodridge Drive.


