ITEM HISTORY:

In the fall of 2013, the Village drew down on the letter of credit (LOC) security for the Cedar Hills Townhome Development due to the incompletion of the required detention pond improvements by the developer and failure to achieve compliance with the standards of the DuPage County Countywide Storm water and Floodplain Ordinance.

In 2014, the Village hired Encap to complete the first year of treatment including cutting and removing vegetation and conducting herbicide treatments in order to prevent the condition of the plantings from further deteriorating.

ITEM DISCUSSION:

This bid is for the balance of the Cedar Hills Detention Basin Restoration Project.

A notice was published in the Daily Herald on March 12, 2015. The Village received seven (7) bid proposals and the bids were opened on March 31, 2015.

Bid Results:

The lowest bid in the amount of \$23,241 was received from Native Landscaping Contractors, LLC. The Village Engineer's estimate for the project's construction was \$21,804. The bid from Native Landscaping Contractors, LLC was responsive and meets the project specifications. They have completed similar work for the Village of Montgomery, Chicago Botanic Gardens, and HUB

Group. Although staff has not had prior experience working with Native Landscaping Contractors, Inc. the references called were all positive.

This project is budgeted in this current year and funded from the drawdown of the LOC security of \$92,894. Costs of the Village's engineering consultant and staff time will also be deducted from the LOC.

Public Works is recommending the Village Board award Bid 2015-04 to Native Landscaping Contractors, Inc. in the amount of \$23,241.
