ITEM HISTORY:

In 2015, the Village awarded Bid #2015-06, Turf Maintenance Services, to Beary Landscaping. This contract is specific to turf maintenance/ lawn mowing of 83 acres (rights of way, medians and public properties) one time per week for 7 months. There were six (6) bids in total submitted for the contract with one bid proposal from Alaniz Group Inc. rejected for failing to correctly and completely respond to the bid. The lowest responsive bid for Bid 2015-06 was from Beary Landscaping at \$52,150 and was awarded for the period ending March 31, 2016.

ITEM DISCUSSION:

At the Village's sole discretion, Bid #2015-06 provides for the option to extend the contract for three (3) separate one (1) year extensions. Aside from the 2015 season, Beary Landscaping was awarded this contract for the 2011-2013 seasons with a contract extension for the 2014 season. Beary Landscape has done an exceptional job completing the contract scope, has been very professional with staff, and has had no safety concerns or other issues with performance.

This first extension year (2016-17) was bid with a 3% increase for the 2016 contract period for an annual amount of \$53,714.50, an increase of \$1,564.50. This service is currently budgeted at \$57,500 under Forestry — Professional Services in the CY 2016 Budget. Public Works staff recommends awarding a one (1) year extension of the Turf Maintenance Services Contract for the period of April 1, 2016 to March 31, 2017 to Beary Landscaping.
