ITEM DISCUSSION:

This project is for the resurfacing of the following parking lots: Village Hall, Library, Public Works, Public Works Yard, Police, Police Rear Lot, Post Office, and the portion of Plaza Drive to the east of the Post Office. It also includes miscellaneous sidewalk and curb replacement as well as pavement markings.

The Village will be reimbursed by the Library and Post Office for their respective lots.

This project was bid out and the Village received four (4) bid proposals.

Bid Results:

The lowest bid in the amount of \$324,445.25 was received from Orange Crush, LLC. Which was considerably lower than the engineer's cost estimate of \$447,568. The bid from Orange Crush, LLC was responsive and meets the project specifications.

The Village's estimated share of the project is \$265,000. This project is budgeted for in this fiscal year at \$300,000. his project is budgeted in this current year at \$300,000.

Although staff has not had prior experience working with Orange Crush, LLC, they have performed similar work for both the Bolingbrook Park District and Joliet Junior College. They have also constructed parking lots for private developments in Internationale Centre. All references were positive stating that they did reliable and quality work and that they would work with them again.
