ITEM HISTORY:

The 2015 MFT Resurfacing Project (#15-00000-01-GM) includes the full depth resurfacing of the following two (2) streets: Bradley Drive (63rd Street to Woodridge Drive), Clark Drive (63rd Street to Bradley Drive). The improvements also include the minor resurfacing of the following fourteen (14) streets: 63rd Street, Halsey Court, Bonnie Court, Sioux Avenue, Seminole Court, Chestnut Court, Willow Avenue, Willow Lane, Highland Court, Mohawk Avenue, Carlton Drive, Manchester Court, Ridgeway Drive and Jackson Drive (See attached 2015 MFT Resurfacing Map).

This project is budgeted at \$1,035,000 with \$980,000 in the Motor Fuel Tax Fund (204-3470-431-6065) and \$55,000 in the General Fund (101-3440-431-3088).

Proposed work is to remove and replace all of the asphalt on the streets to be full depth resurfaced, and a 1.5" mill and resurface of those streets designated as minor resurfacing. Miscellaneous curb and sidewalk repairs, miscellaneous driveway repairs, miscellaneous storm sewer repairs, pavement patching and pavement markings throughout the Village and all other related work will be completed as well.

This project is funded from the MFT Appropriations approved by the Village Board on January 15, 2015.

ITEM DISCUSSION:

This contract was advertised on March 17, 2015. Nine (9) responsive bids were received and reviewed by Village staff. The bids ranged from a high of \$1,087,198.94 from R.W. Dunteman Co. to a low of \$856,672.20 from G.A. Paving LLC (\$858,611.95 on the "As Read" Bid Tally). The Engineer's Estimate for the project was \$1,034,987.59. All bidders submitted Bid Bonds in the amount of five (5) percent of their total bid as required by the contract documents. The attached bid tabulation shows the items and specifications breakdown.

G. A. Paving LLC is the low, responsive bidder and they meet our specifications. They are in good standing with IDOT.

The contracts have been forwarded to the contractor for execution. Once Public Works receives the executed contracts along with bond and insurance requirements, they will be forwarded for execution by the Village Board.
