Notice published in the Daily Herald on March 2, 2015 with a Bid Opening Date of March 17, 2015.

Number of Bids Received: 4

ITEM DISCUSSION:

This capital maintenance project is budgeted in account number 501-3452-432.60-63 as part of the overall sanitary sewer maintenance and rehabilitation program. This project entails flushing and full cleaning, including root removal, and televising with a report generated of the condition 84,000 linear feet that makes up Basin E (the sanitary sewer collection basin east of I355, between 75th Street on the north and I55 on the south). Basin E, along with Basin F in the Seven Bridges area, is largely comprised of plastic main and is the newest of the basins.

This basin cleaning and televising program is a major tenet of the overall capital improvement program for the system as it completes the needed routine heavy cleaning, and the televising enables a detailed inspection of the system for problems in need of repair.

Public Works has reviewed the four (4) bids that were received in response to bid #2015-01, Sewer Televising and Cleaning – Basin E. The bid summary is as follows:

4	National Power Rodding	\$275,901.51

The low bid from Hydro-Vision Technology LLC at \$105,486.88 was responsive to all bid requirements. Hydro-Vision has done multiple jobs for the Village including the 2014 Televising and Cleaning Project of Basic B, post storm televising and cleaning of the Crabtree Avenue trunk line, and the spot television and cleaning project in Basin E and Basin F. Hydro-Vision has been professional, efficient, and completed high quality work.
