ITEM HISTORY:

The Seven Bridges Northwest Quadrant Project (bid #2013-04), includes earthwork, parking lot paving, as well as brick paver and concrete sidewalk installation, which was never completed by the developer. This project will be completely funded through a Letter of Credit that the Village secured from the developer of the Seven Bridges Retail Development. This project is budgeted at \$335,960 in account #301-0000-211-2800. The Letter of Credit in the amount of \$533,000 will be used to cover engineering and staff costs as well.

ITEM DISCUSSION:

On Wednesday, June 12, 2013 at 10:00 a.m. sealed bids for the Seven Bridges Northwest Quadrant Project were opened and read aloud. A total of two bids were received and reviewed by the Village Staff. A third bid was received after the deadline and was rejected.

The attached tabulation shows the amounts bid. The Engineers Estimate for this project was \$303,312.90.

ALamp Concrete Contractors, Inc. is the apparent low, responsive bidder and they meet our project specifications. Additionally, ALamp Concrete Contractors, Inc. has completed several paving and sidewalk installation projects for the Village in the past and always did an excellent job. ALamp Concrete Contractors, Inc. is also an Illinois Department of Transportation (IDOT) Prequalified Contractor.

It is Public Works recommendation to award the contract to ALamp Concrete Contractors, Inc. in the amount of \$274,841.
