#### ITEM HISTORY:

The 2013 MFT Resurfacing Project (#14-00000-01-GM) includes the resurfacing of Audubon Avenue (Janeswood Drive to Kildeer Court), Cherry Tree Avenue (Yellow Star Street to Janeswood Drive), Chestnut Avenue (Jonquil Lane to End), Dove Avenue (Wren Court to Goldfinch Street), Foxtree Avenue (Yellow Star Street to Janeswood Drive), Goldfinch Street (Janes Avenue to Redwing Court), Lee Street (Jackson Drive to Hobson Road), Redwing Court (Redwing Drive to End), Redwing Drive (Janes Avenue to Redwing Court), Westview Lane (Everglade Avenue to 83rd Street), Yellow Star Street (Janeswood Drive to Cherry Tree Avenue). Also miscellaneous roadway surface patching and pavement markings will be installed at various locations throughout the Village. This project is funded from the Motor Fuel Tax Fund, 204-3470-431-6065 in the amount of \$523,000.

On February 28, 2013 the Village Board approved Resolution #2013-9 appropriating MFT Funds for this project.

#### ITEM DISCUSSION:

This contract was reviewed and then advertised. Five responsive bids were received and reviewed by Village staff.

The attached bid tabulation shows the items and specifications breakdown. The Engineers Estimate for this project was \$524,179.50.

James D. Fiala Paving is the low, responsive bidder and they meet our specifications. They are in good standing with IDOT, and have completed several roadway improvements projects for the Village of Woodridge in the past.
