# ITEM HISTORY:

In 2014 a request had been raised for installation of a traffic signal at the intersection of Woodridge Drive / 83<sup>rd</sup> Street. The Public Works and Police Department, along with a professional traffic engineer, conducted an evaluation of the intersection. The conclusion from the study was that it did not meet the warrants for a signalized intersection, but could potentially merit a signal in the future dependent on additional increases in traffic volume. The study confirmed that a modification to the intersection by creating separate left and right turn bays for southbound Woodridge Drive (going onto 83<sup>rd</sup> Street) would be an alternative option to pursue.

This proposed modification to the turning configuration would improve the level of service at the intersection at a far lesser cost than a traffic signal, particularly during peak periods. The modification would potentially improve the issue to a point that a signal would not be required in the future (dependent on future traffic volumes) and the work would establish geometry at that leg of the intersection which would be necessary in the future should a signal ever be installed.

This project was originally budgeted and bid in 2015. The Village Engineer's estimate for the project was approximately \$50,000. However, the low bid of \$90,308 was rejected based on the limited interest and high price. The project was re-budgeted for 2016 and re-bid on April 16, 2016.

# **ITEM DISCUSSION:**

Public Works has reviewed the bids that were received in response to Bid #2016-04 on May 3, 2016. A total of four (4) bids were received. The lowest bid in the amount of \$67,900.00 was received from Chicagoland Paving Contractors, Inc.

The bid from Chicagoland Paving Contractors, Inc. was responsive and meets the project specifications. They are in good standing with IDOT and have completed roadway improvement projects successfully for IDOT and other municipalities in the past. Chicagoland Paving will also be completing the Village's CDBG/MFT project later this summer.

Public Works is recommending the Village Board award Bid #2016-04 to Chicagoland Paving Contractors, Inc. in the amount of \$67,900.00. The budget includes \$65,000 for this project. The \$2,900 difference will be made up from other line items and projects in the budget.
