ITEM HISTORY:
 The Village of Woodridge and the Woodridge Park District separately own adjacent sections of property along Crabtree Creek, west of Woodridge Drive and east of Westview Lane, and are simultaneously pursuing stabilization projects on our respective properties for a more regional improvement. The Village identified this section of Crabtree creek (stream reaches 26, 28.1, and 30) as a higher priority section for stabilization work following the 2008 study of the streambanks and other storm water infrastructure. This project will include the installation of gabion baskets, planting of new native deep rooted vegetation, and the installation of stone riffles designed to dissipate energy and channel the flow within the banks.

ITEM DISCUSSION:
 The Village advertised Bid #2016-05, Crabtree Creek Streambank Stabilization, on June 12 2016 (Woodridge Park District is currently out to bid and has a bid opening scheduled for July 27, 2016). On June 28, 2016 a bid opening for this project was held and a total of nine (9) bids were received. The lowest bid in the amount of \$168,081.00 was received from Nettle Creek Nursery, Inc.

The bid from Nettle Creek Nursery, Inc. was responsive and meets the project specifications. The Village of Westmont, Village of Home Glen, Crystal Lake Park District and Elk Grove Village were satisfied with the work that Nettle Creek Nursery, Inc. performed in their communities.

Project Funding:
 Both the Village and Park District have received a grant from the DuPage County Water Quality Improvement Program for stabilization work on their respective properties. This grant from

DuPage County covers 25% of the project cost or a maximum of \$37,899. In addition to the grant for DuPage County, the Village and Park District were awarded a grant from the IEPA that would cover 59% of the combined total of both the Village and Park District projects which is estimated at \$282,740 (the Village project at \$164,736 and the Park District estimated at \$118,000). The grant will be reimbursed to the respective agency based on the proportionate share of the project, 58.6% to the Village and 41.4% to the Park District. The estimated total local share for the Village of Woodridge is estimated at \$34,183 with final numbers subject to change based on the Park District Bid and resulting change in the grant reimbursement based on project totals.

The CY2016 budget included a \$260,000 expenditure for the engineering work and construction of this stabilization project as well as the reimbursing revenue from both grants.
