**ITEM HISTORY:**  
 The 2016 MFT Resurfacing Project (#16-00000-01-GM) includes the full depth resurfacing of six (6) streets. The improvements also include the minor resurfacing of twelve (12) streets. See Exhibit A for the full list of streets and Exhibit B for a map of the improvements.

This project is budgeted at \$1,077,406.00 with \$1,047,406.00 in the Motor Fuel Tax Fund (2103110-460600) and \$30,000 in the General Fund (1013142-430340).

Proposed work is to remove and replace all of the asphalt on the streets to be full depth resurfaced, and a 1.5" mill and resurface of those streets designated as minor resurfacing. Miscellaneous curb and sidewalk repairs, miscellaneous driveway repairs, miscellaneous storm sewer repairs, pavement patching and pavement markings throughout the Village and all other related work will be completed as well. The MFT Appropriations for this work was approved by the Village Board on February 4, 2016.

**ITEM DISCUSSION:**  
 On Thursday, April 14, 2016 at 11:00 A.M. sealed bids for the 2016 MFT Resurfacing Project were opened and read aloud. The bid for the project contained a base bid and an alternate bid to allow the Village to resurface additional streets if bid prices for the base bid came in below the budgeted amount. A total of nine (9) contractors submitted bids for the project – the full bid tabulation is attached. All bidders submitted Bid Bonds in the amount of five (5) percent of their base bid as required by the contract documents. The Combined Bid is the Base Bid plus the Alternate Bid.

The bid by Brothers Asphalt Paving, Inc., the apparent low bidder, was responsive and met the project specifications. They are in good standing with IDOT and have completed roadway improvement projects successfully for IDOT and other municipalities in the past, including the 2014 CDBG/MFT Resurfacing Project for Woodridge.

For reference, the Village's past several resurfacing projects final completed cost have varied from the award cost due to increases or decreases in estimated quantity for pay items (i.e. reduced quantity of concrete repairs, additional base replacement, etc.).
